

2009 Real Estate Assessments List Of Changes And Divisions

The following is the 2009 Real Estate Assessments list of changes and divisions together with the amount of assessments as made by the Township Assessor and by the Chief County Assessment Officer.

Real property, other than farmland, farm buildings and coal, is required to be assessed at 33 1/3% of fair cash value in accordance with 35 ILCS 200/9-145.

The assessed values herein shown, except farmland, farm buildings and coal, are subject to equalization by the Chief County Assessment Officer and revision and equalization by the Carroll County Board of Review and the Dept. of Revenue.

35ILCS 200/Sec 17-5 provides that the Dept. shall lower or raise the total assessed value of the property in any county so that such property will be assessed at its Fair Cash Value as defined in 35 ILCS 200/Sec 1-50 of the Revenue Act.

This publication (made in accordance with ILCS 200/Sec 12 of the Property Tax Code) provides for the public notice to the taxpayers of the assessed value fixed upon their property by the Township Assessor or the Chief County Assessment Officer.

The median level of assessment for the assessment district is 33.33. Your property is to be assessed at the median level of assessment for your assessment district. You may check the accuracy of your assessment by dividing your assessment by the median level of assessment for your assessment district. If the resulting value is greater than the estimated fair cash value of your property, you may be over-assessed. If the resulting value is less than the estimated fair cash value of your property, you may be under-assessed.

Taxpayers who consider their properties incorrectly assessed may file a complaint on the forms provided, with the Board of Review through the 21st of January, 2010, in person or by writing the Board of Review, Carroll County, P.O. Box 227, Mt Carroll, IL 61053.
