

Notice of Proposed Property Tax Increase for Lanark Fire Protection District

I. A public hearing to approve a proposed property tax levy increase for the Lanark Fire Protection District for the fiscal year beginning May 1, 2008 and ending April 30, 2009, will be held on October 8, 2008, at 6:45 p.m., at the Lanark Fire Protection District Building, Lanark, Illinois.

II. The corporate and special purpose property taxes extended for the 2007/2008 fiscal year were \$330,650.00.

The proposed corporate and special purpose property taxes to be levied for fiscal year 2008/2009 are \$541,131.00. This represents a 63.66% increase over the previous year.

III. The property taxes extended for debt service and public building commission lease for fiscal year 2007/2008 were \$0.

The estimated property taxes to be levied for debt service and public building commission leases for fiscal 2008/2009 are \$0. This represents a 0% increase over the previous year.

IV. The total property taxes extended for fiscal year 2007/2008 were \$330,650.00.

The estimated total property taxes to be levied for fiscal year 2008/2009 are \$541,131.00. This represents a 63.66% increase over the previous year.

PROPOSED CALL FOR A CONSTITUTIONAL CONVENTION

Explanation of Proposed Call

This proposal deals with a call for a state constitutional convention. The last such convention was held in 1969-70, and a new Constitution was adopted in 1970. The 1970 Illinois Constitution requires that the question of calling a convention be placed before the voters every 20 years. In 1988 the electors rejected the call for a constitutional convention, with 75% voting against calling a convention and 25% voting in favor of calling a convention. If you believe the 1970 Illinois Constitution needs to be revised through the convention process, vote "YES" on the question of calling a constitutional convention. If you believe that a constitutional convention is not necessary, that changes can be accomplished through other means, vote "NO" on the calling of a constitutional convention.
