NOTICE OF PROPOSED PROPERTY TAX INCREASE FOR CARROLL COUNTY

- I. A public hearing to approve a proposed property tax levy increase for Carroll County for 2008 will be held on November 20th, 2008 at 9:30 a.m. at 301 N. Main., Mt. Carroll, Illinois in the Carroll County Courthouse Court Room B.

- II. The corporate and special purpose property taxes extended or abated for 2007 were \$2,216,896.00.
The proposed corporate and special purpose property taxes to be levied for 2008 are \$2,824,425.00. This represents a 27.40% increase over the previous year.
- III. The property taxes extended for debt service and public building commission leases for 2007 were \$0.00.
The estimated property taxes to be levied for debt service and public building commission leases for 2008 are \$0.00. This represents a 0% over the previous year.
- IV. The total property taxes extended or abated for 2007 were \$2,216,896.00.
The estimated total property taxes to be levied for 2008 are \$2,824,425.00. This represents a 27.40% over the previous year.
