

ORDINANCE 2011-2

AN ORDINANCE TO LEVY
AND ASSESS A TAX FOR
CHADWICK PUBLIC
LIBRARY DISTRICT OF THE
COUNTIES OF CARROLL
AND WHITESIDE, STATE OF
ILLINOIS FOR THE FISCAL
YEAR BEGINNING JULY 1,
2010 AND ENDING JUNE 30,
2011

BE IT ORDAINED, that the Chadwick Public Library District of the Counties of Carroll and Whiteside and the State of Illinois shall levy a tax of .02% of the value of all taxable property within said District, for building and maintenance purposes, subject to the right of the electors in said District to petition and require an election concerning the imposition of such tax, pursuant to 75 ILCS 16/35-5.

BE IT FURTHER ORDAINED, that within fifteen days from the date of adoption of the ordinance, it shall be published in The Prairie Advocate, a newspaper of general circulation in the Chadwick Public Library District and it is effective immediately upon adoption.

Bid Notice

Sealed bids will be received for Bid Release No. 2 for the **Eastland High School Additions and Renovations Project** until **2:00 p.m., prevailing time, on Wednesday, June 30, 2010**, by the Board of Education, Eastland Community Unit School District Number 308, Counties of Carroll, Stephenson and Ogle Counties, State of Illinois, at the District Office, 200 S. School Street, Lanark, IL 61046. All bids received after said date and time shall not be considered and returned unopened. All bids must be submitted on the forms furnished in the Bidding Documents. The project will be bid as separate trade contracts, which are as follows:

BP #2B - Site Concrete & Asphalt Paving

BP #3 - Cast-in-Place Concrete

BP #4 - Masonry

Each bid must conform and be responsive to all pertinent Bidding and Contract Documents. Bids shall be submitted on or before the specified closing time in an opaque sealed envelope marked "Eastland High School Additions and Renovations Bid Release No. 2, Bid Package # _____" on the outside and addressed to: Mr. Mark Hansen, Superintendent,

Eastland CUSD No. 308, 200 S. School Street, Lanark, Illinois 61046. Bids shall be opened publicly and the contents announced at the specified closing time. Bids may be held by the School District for a period of ninety (90) days from the date of bid opening for the purpose of reviewing the Bids and investigating the qualifications of Bidders prior to awarding the contracts.

Bid security in the form of a bid bond or certified check made payable to the Board of Education, Eastland Community Unit School District Number 308 equal to 10% of the base bid amount shall be submitted with the bid. Performance and Labor and Material Payment Bonds, and Certificate of Insurance will be required from the successful bidder.

The Board of Education for Eastland Community Unit School District Number 308 reserves the right to reject any or all bids or parts thereof, to waive any irregularities or informalities in the bidding procedures and to award the contracts in a manner serving the interest of the School District. Additionally they reserve the right to amend the bid documents, including the plans and specification, Scope of Work Notes and

Supplemental Conditions, at any time prior to the bid opening, with reasonable notice to the bid package holders.

This project is subject to the State of Illinois Prevailing Wage requirements for Carroll County, IL, "Illinois Prevailing Wage Act" (Ill. Rev. Stat., 1987 Ch. 48, Sections 398 x-1-12 as amended by Public Act 86-693 and 86-799 effected January 1, 1990).

Bidding documents which include Construction Manager's Scope of Work Notes, Architects Project Manual and Plans will be available on CD after 2:00 p.m. Monday, June 14, 2010. Paper drawings are available at additional cost to the bidder. Documents can be picked-up or shipped through BHFX (847) 742-2876. PLEASE CALL IN ADVANCE FOR AVAILABILITY. A UPS account number will be required for all shipments.
