ORDINANCE 2010-2

AN ORDINANCE TO LEVY AND ASSESS A TAX FOR CHADWICK PUBLIC LIBRARY DISTRICT OF THE COUNTIES OF CARROLL AND WHITESIDE, STATE OF ILLINOIS FOR THE FISCAL YEAR BEGINNING JULY 1, 2009 AND ENDING JUNE 30, 2010

BE IT ORDAINED, that the Chadwick Public Library District of the Counties of Carroll and Whiteside and the State of Illinois shall levy a tax of .02% of the value of all taxable property within said District, for building and maintenance purposes, subject to the right of the electors in said District to petition and require an election concerning the imposition of such tax, pursuant to 75 ILCS 16/35-5.

BE IT FURTHER ORDAINED, that within fifteen days from the date of adoption of the ordinance, it shall be published in the Prairie Advocate, a newspaper of general circulation in the Chadwick Public Library District and it is effective immediately upon adoption.
