ANNUAL BUDGET & APPROPRIATION ORDINANCE FOR HANOVER COMMUNITY FIRE PROTECTION DISTRICT
For the Fiscal Year thereof beginning May 1, 2009 and ending April 30, 2010

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF HANOVER COMMUNITY FIRE PROTECTION DISTRICT, Jo Daviess County, Illinois and Carroll County, Illinois, as follows:

SECTION 1: That the current fiscal year of said Hanover Community Fire Protection District be and the same is hereby fixed and determined to be the period beginning May 1, 2009 and ending April 30, 2010.

SECTION 2: That the following budget, which contains a statement of the cash on hand at the beginning of said fiscal year, an estimate of the receipts and expenditures of said Fire Protection District for such fiscal year, and an estimate of the amount of cash which will be on hand at the end of such period, be and the same hereby is adopted as the Budget and Appropriation Ordinance of Hanover Community Fire Protection District for said fiscal year, to-wit:

SECTION 4: The unexpended balances of any item or items of any general appropriation made by this ordinance may be expended in making up any deficiency in any item or items of the same general appropriation made by this ordinance.

SECTION 5: For the levy and collection of taxes the rate shall not be in excess of .30% of the value of all taxable property within the District equalized and assessed by the Department of Revenue.

SECTION 6: This Ordinance shall be published within thirty (30) days after its passage in The Prairie Advocate.

SECTION 7: That this Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
