School Street, Lanark, IL 61046. All bids received after said date and time shall not be considered and returned unopened. All bids must be submitted on the forms furnished in the Bidding Documents. The project will be bid as separate trade contracts, which are as follows:

School Street, Lanark, Illinois 61046. Bids shall be opened publicly and the contents announced at the specified closing time. Bids may be held by the School District for a period of ninety (90) days from the date of bid opening for the purpose of reviewing the Bids and investigating the qualifications of Bidders prior to awarding the contracts.

**Bid security in the form of a bid bond or certified check made payable to the Board of Education, Eastland Community Unit School District Number 308 equal to 10% of the base bid amount shall be submitted with the bid. Performance and Labor and Material Payment Bonds, and Certificate of Insurance will be required from the successful bidder.**

**The Board of Education for Eastland Community Unit School District Number 308 reserves the right to reject any or all bids or parts thereof, to waive any irregularities or informalities in the bidding procedures and to award the contracts in a manner serving the interest of the School District. Additionally they reserve the right to amend the bid documents, including the plans and specification, Scope of Work Notes and Supplemental Conditions, at any time prior to the bid opening, with reasonable notice to the bid package holders**

This project is subject to the State of Illinois Prevailing Wage requirements for Carroll County, IL, “Illinois Prevailing Wage Act (Ill. Rev. Stat., 1987 Ch. 48, Sections 398 x-1-12 as amended by Public Act 86-693 and 86-799 effected January 1, 1990).
